ISU Ice Dance Development Training Seminar for Coaches and Ice Dance couples – Novice and Junior

A. ISU Ice Dance Development Training Seminar for Coaches and Ice Dance couples Junior age category

The ISU announces that the Ice Dance Technical Committee through an initiative supported by the ISU Development Program is organizing an International Ice Dance Development Training Seminar for coaches and ice dance couples of Junior age and level in:

Oberstdorf, Germany, April 5th to April 17th, 2011

The aim of the Seminar is the development of Ice Dance couples of Junior age category to a high level and the introduction of Ice Dance in new areas where it is not yet traditionally pursued. Top, world-class coaches will moderate the Seminar. Daily off-ice classes which will include ballet, lifts, relaxation/yoga, movement to music, ballroom-dancing and dance technique lectures. For a more personal learning effect, the experts will be available for a one-to-one contact with participating coaches.

The moderators for this seminar are: Mrs. Krisztina Regöczy (ISU), Mrs. Carol Lane (CAN), Mr. Robbie Kayne (USA), Dr. Rostislav Sinitsin (CZE), Mrs. Diana Munyakazi (GER), Mr. Ronald Keipert (GER) and one additional moderator TBC.

The 2011 Ice Dance Seminar is composed for Junior aged couples with the following requirements:

Group A (younger group)

has reached the age of 13 but not the age of 16 for Ladies and have reached the age of 13 but not the age 18 for Men by July 1st preceding the seminar;

Group B (older group)

has reached the age of 16 but not the age of 19 for Ladies and have reached the age of 16 but not the age of 21 for Men by July 1st preceding the seminar.

Each Member may enter couples with no limitation plus a not limited number of coaches to the Seminar. In case of too many couples entered, the ISU will reduce the number using primarily the age criteria and/or the region as limitation, starting from the highest age.

In addition, the Ice Dance Technical Committee will check the list of entries and accept only participants (skaters and/or coaches) for which it sees a possibility of future development in ice dancing.

The Seminar is also open to coaches wishing to attend without skaters.

Expenses

The responsibility for the Junior Seminar is as follows:

- a) The living expenses (room and meal) for the accepted competitors and 2 coaches per Member with participating Junior skaters will be borne by the ISU for the period from dinner on Tuesday, April 5th, 2011 to breakfast on Sunday, April 17th, 2011;
- b) Members will be responsible for all travel expenses for coaches and skaters, and the living expenses for coaches, attending, but being outside of the quota or coaches without a participating couple.

Participants should arrange to arrive on Tuesday, April 5th, 2011 and depart in the morning of April 17th, 2011.

B. ISU Ice Dance Development Training Seminar for Coaches and Ice Dance couples Novice age category

The aim of the Seminar is the development of Ice Dance couples of Novice age category to a high level and the introduction of Ice Dance in new areas where it is not yet traditionally pursued. Top, world-class coaches will moderate the Seminar. Daily off-ice classes which will include ballet, lifts, relaxation/yoga, movement to music, ballroom-dancing and dance technique lectures. For a more personal learning effect, the experts will be available for a one-to-one contact with participating coaches.

The 2011 Ice Dance Seminar is composed for Novice aged couples with the following requirements:

Age Novice category

has reached the age of 10 but not the age of 15 for Ladies and Men, preceding the seminar.

Each Member may enter couples with no limitation plus a not limited number of coaches to the Seminar. In case of too many couples entered, the ISU will reduce the number using primarily the age criteria and/or the region as limitation, starting from the highest age.

In addition, the Ice Dance Technical Committee will check the list of entries and accept only participants (skaters and/or coaches) for which it sees a possibility of future development in ice dancing.

The Seminar is also open to coaches wishing to attend without skaters.

Expenses

The responsibility for the Seminar is as follows:

- a) The living expenses (room and meal) for the accepted competitors and 2 coaches per Member with participating Novice skaters will be borne by the ISU for the period from dinner on Tuesday, April 19th, 2011 to breakfast on Sunday, May 1st, 2011;

- b) Members will be responsible for all travel expenses for coaches and skaters, and the living expenses for coaches, attending, but being outside of the quota or coaches without a participating couple.

Participants should arrange to arrive on Tuesday, April 19th, 2011 and depart in the morning of May 1st, 2011.
