Judges Draw by number for ISU Figure Skating Championships 2012

Further to Rule 582, Rule 660 and Rule 972 of the ISU Special Regulations and Technical Rules for Single & Pair Skating and Ice Dance, and the Special Regulations and Technical Rules for Synchronized Skating 2010, the draw for Judges by number for the above-mentioned Championships was held on October 12, 2011, at the Hotel Hilton in Zürich in the presence of Mr. David Dore, ISU Vice-President Figure Skating, Mr. Peter Krick, Chair Sports Directorate, Ms. Patricia Mayor, ISU Sports Coordinator Figure Skating, Mr. Roland Wehinger, President of the Schweizer Eislauf Verband and Mr. Philippe Dünner, auditor from BDO Visura.

- Ladies 5 Members, out of the 13 Members drawn for the Ladies Championships and 4 Members out of the 13 Members drawn in the Pairs Championships will form the panel of Judges for the Ladies Preliminary Round.
- Pairs 9 Members out of the 13 Members drawn for the Pairs Championships will form the Pair panel for the Pairs Preliminary Round. 8 Judges are the Judges, already included in the panel for the Men and Ladies qualification; an additional Judge will be drawn from the remainder of the Pair panel.

- c) Immediately following the draw procedure for the respective Championships the draw for the panels of the Preliminary Round of these Championships will follow. The composition will be made as follows:

- Ice Dance 9 Members out of the 13 Members drawn for the Ice Dance Championships will form the Ice Dance panel for the Ice Dance Preliminary Round.
