B. Trial Judging

Official Trial Judging, as per rule 818 paragraph 9a) (1) and 10c) will be conducted by the ISU Synchronized Skating Technical Committee in connection with the French Cup, the ISU Synchronized Skating International Competition for Seniors and Juniors which will be held in:

Rouen, France, January 31st – February 3rd, 2008

Acting as a Trial Judge in this designated International Synchronized Skating Competition will be considered as activity for present International Judges/Referees.

Those ISU Members needing to provide activity either for their present International Judges/Referees or their National Judges who before April 15th 2008 will be nominated by the respective ISU Members as International Synchronized Skating Judge, must send applications to the ISU Secretariat with a copy to the member of the Synchronized Skating Technical Committee, Mrs. Helen Volgushev, not later than **December 30th 2007**.

The total number of participants for Trial Judging is limited and therefore, the Synchronized Skating Technical Committee will make the final selections from the applications submitted.

Program:

The Trial Judging will use the ISU Judging System and will consist of different parts of Short Program and/or Free Skating in Senior and Junior categories.

All participants must plan to arrive at the official hotel on Thursday January 31st 2008 before 16.30hrs and should plan to leave Rouen on Sunday February 3rd 2008 after 12.00hrs.
