## Communication No. 1910

### Officials' remuneration for ISU Events

This Communication replaces Communication No. 1794 with immediate effect. Changes compared to Communication No. 1794 are underlined.

#### 1. On-site:

The OC must pay to the Officials the following remuneration:

- a) Senior Grand Prix of Figure Skating events and Final and World Team Trophy  
CHF 300 per event or Final for all Officials
- b) Junior Grand Prix of Figure Skating events:  
CHF 200 per event and Final for all Officials
- c) ISU Figure Skating Championships:  
The OC must pay to the Officials, the following remuneration for ISU Championships:
  - Technical Specialists, Technical Controllers and Data and Replay Operators receive a gross amount of CHF 350.00
  - Referees, Judges and OAC Members in Single & Pair Skating and Ice Dance gross amount CHF 300.00
- d) ISU Synchronized Skating Championships (excluding the ISU Synchronized Skating Junior World Challenger Cup):  
The OC must pay to the Officials, the following remuneration for ISU Championships:
  - Technical Specialists, Technical Controllers and Data and Replay Operators receive a gross amount of CHF 200.00
  - Referee, Judges and OAC Members a gross amount of CHF 150.00

The amount must be either in Swiss Francs or in the currency of the organizing ISU Member, provided it is hard currency. This money is to be distributed at Registration.

#### 2. After the season:

For Officials having officiated without demotion or suspension during the season

at 3 ISU Events: Additional CHF 500

at 4 ISU Events: Additional CHF 600

at 5 ISU Events: Additional CHF 700

etc. (CHF 100 increment for each additional Event)

As an example, an Official having officiated during a season at 4 ISU Events without any suspension or demotion, would receive the following compensation:

1 <sup>st</sup> Event on site Senior GP from organizer	CHF 300
2 <sup>nd</sup> Event on site Senior GP from organizer	CHF 300
3 <sup>rd</sup> Event on site Junior GP from organizer	CHF 200
4 <sup>th</sup> Event on site Championships from organizer	CHF 300
at end of season from ISU	CHF 600
Total season	CHF 1'700

Officials that after the procedure outlined under ISU Communication No. 1893, have been suspended and/or demoted, will not receive the compensation after the season and must reimburse all compensation moneys received at ISU Events during the season concerned to the respective organizing Members. Failing to do so will result in the Official not being allowed to resume his/her officiating activity at ISU sanctioned competitions until the outstanding reimbursement has been made.

3. OAC members acting at their residence  
Per Event: CHF 50.
